# **Project Overview**



**Anticipated Cost – \$1.9 million** 

**Purpose** – To replace the structurally deficient bridge over Piney Creek Creek

**Location** – About 0.1 mile north of Route 665 (Buck Mountain Road)

**Improvements –** Replace the existing timber deck bridge with a slightly wider concrete slab bridge with an asphalt riding surface.

State Project – 0667-002-932, P101, R201, B683 Federal Project – STP-5104(261)

# **PROJECT DESCRIPTION**

This project will replace the existing Route 667 (Catterton Road) bridge over Piney Creek in Albemarle County.

The existing timber deck bridge was built in 1932 and is considered structurally deficient.

VDOT proposes replacing the existing timber deck bridge with a slightly wider concrete slab bridge with an asphalt riding surface.

During construction, Route 667 will be closed to through traffic near 665 (Buck Mountain Road) with a posted detour. Drivers will detour via Route 601 (Free Union Road) and Route 665.

Construction is expected to begin in spring 2023


The Route 667 bridge carries approximately 130 vehicles per day.

Once construction is complete in spring 2024, the bridge will be open to all legal weight vehicles.

The design of this project is in compliance with the Stormwater Management Act, stormwater regulations and the annual stormwater management standards and specifications approved by the Virginia Department of Conservation and Recreation. The construction of this project will conform to the nationwide best management practices, VDOT specifications and special provisions, and the Virginia Department of Soil and Water conservation regulations.

During construction, every reasonable effort will be made to protect the environment with respect to dust and erosion control. Access to all properties will be maintained during construction.

#### **Environmental Review**

VDOT's Culpeper District Environmental office has performed environmental reviews and coordination to obtain information about environmental resources in the project vicinity; to provide natural and historic resource agencies an opportunity to review and comment on the project during its development; and to identify opportunities for avoidance, minimization and mitigation of potential environmental impacts.

The National Environmental Policy Act (NEPA) is applicable to this project and required documentation has been developed in cooperation with the Federal Highway Administration and in accordance with federal guidelines.

All required environmental clearances and permits will be obtained prior to commencement of construction. Strict compliance with all environmental conditions and commitments resulting from regulatory approvals and implementation of VDOT's specifications and standard best management practices will protect the environment during construction.

The replacement of the Route 667 bridge over Piney Creek will not require the displacement of any families, businesses or non-profit organizations.

The property owners will be informed of the exact location of the easements during the right of way acquisition process and prior to construction.

Information about right of way purchase is discussed in VDOT's Right of Way and Utilities brochure, "A Guide for Property Owners and Tenants." Copies of this brochure are available on the VDOT website and from any VDOT Right of Way agent.
